Feedback

We recently conducted a web-based survey of the AIA EPC's events and activities. The findings, based on a small but representative cross section of the Chapter, indicated that the Board is meeting the Member's needs in terms of programs and locations. It was interesting to note that the majority of respondents both live and work in the Lehigh Valley (Northampton and Lehigh Counties), followed by Berks County as coming in a consistent third for both categories.

Regarding event locations, again respondents prefer meetings between Allentown and Easton/Bethlehem. As for program content, 56% still prefer an AIA/CEU Presentation; followed by Building tours and conventional Architectural Lectures. As for joint meetings with other allied professionals, our membership favors the CSI/AIA events, followed by DVGBC and the Pennsylvania Society of Professional Engineers. So we will look to team with those organizations in the coming year. Interestingly, the respondents seemed to affirm the Boards current direction in meeting venues, meeting times, and event costs. So we will stay the course with those items.

Three teams of students, architects and architectural interns worked to develop sustainable mixed use retail and housing units in downtown Reading.
